Proposed Overseas Travel: Hon Judith Collins KC MP – July 2024

- 1 I seek Cabinet approval to travel to the Kingdom of Tonga over 1 3 by in my capacity as Minister of Defence.
- 2 The Prime Minister has approved the travel in-principle. The House is not sitting during my proposed travel period.

Purpose of Travel

- 3 The purpose of my travel is to attend the opening of Tonga's Pacific Leader Development Centre (Leadership Centre) at His Majesty's Armed Forces (HMAF) Masefield Naval Base, Nuku'alofa. The Leadership Centre is funded by a joint New Zealand Defence Force (NZDF) and New Zealand Ministry of Foreign Affairs and Trade (MFAT), in partnership with His Majesty's Armed Forces (HMAF) and will provide a location for HMAF leadership training, meetings and talanoa (conversation). S^{6(a)}
- 4 Since 2019, New Zealand has been supporting leadership training at all levels in the defence/ paramilitary forces in Fiji, Tonga, Papua New Guinea and Vanuatu through the Pacific Leadership Development Programme (PLDP). The programme supports Pacific forces to take the NZDF Leadership Framework and revise it against their own cultures and organisational needs.
- 5 The PLDP expands NZDF's strong person-to-person links in the region and provides a tangible and ongoing area of collaboration between New Zealand and Pacific Island defence forces. The Leadership Centre itself will be the building in which the wider PLDP training will be based in Tonga and is an important symbol of New Zealand Defence's commitment to work alongside Tonga on capacity development.

The Pacific is crucial to New Zealand's own security and our identity and Tonga, one of three defence forces in the Pacific Islands countries, is a crucial relationship. This will also be a useful opportunity to meet before the South Pacific Defence Ministers' Meeting which I will be hosting in Auckland later this year. 7 Pending Cabinet approval, I plan to depart New Zealand for Nuku'alofa on Monday 1 of July 2024 and arrive in New Zealand from Nuku'alofa on Wednesday the 3 July 2024.

- 9 A delegation from the Ministry of Defence and the New Zealand Defence Force would also accompany me at departmental cost.

Report on Overseas Travel: Hon Judith Collins KC MP – July 2024

I recommend that the Cabinet note this report on my travel to the Kingdom of Tonga from 1 to 3 July 2024.

Report

- 1 I travelled to the Kingdom of Tonga from 1 to 3 July as Minister of Defence to attend the opening of Tonga's Pacific Leader Development Centre (Leadership Centre) at His Majesty's Armed Forces (HMAF) Masefield Naval Base, Nuku'alofa.
- 2 The Leadership Centre is funded by a joint New Zealand Defence Force (NZDF) and New Zealand Ministry of Foreign Affairs and Trade (MFAT) in partnership with His Majesty's Armed Forces (HMAF) and will provide a location for HMAF leadership training.

Opening of the His Majesty's Armed Forces Leadership Centre

3 The Centre, at Touliki Base Masefield, was officially commissioned by His Majesty King Tupou VI. The Chief of the New Zealand Defence Force and I were guests of honour at the opening event. Other attendees included Tonga's Crown Prince, His Royal Highness Prince Tupouto'a Ulukalala (who, as Colonel in Chief of the HMAF, also spoke at the event), other members of Tonga's royal family, Tongan nobles, ministers, diplomatic corps, military veterans and defence representatives from other nations were present.

Meetings marking the occasion

- 4 Prince, Tupouto'a Ulukalala, with a book on Pacific military history. The book tells the story of the Tongan Commandos during the Second World War, who were led by New Zealand Officer LT Ben Masefield, namesake of the Touliki Base Masefield in Nuku'alofa.
- 5 Brigadier Lord Fielakepa, Chief of Defence Staff of His Majesty's Armed Forces, hosted an evening reception to celebrate the official opening of the Leadership Centre. At this event, New Zealand unveiled a mere pounamu made for the centre (and unveiled by the Director of the Leadership

Development programme, Phil Gibbons). This mere pounamu is cut from the same stone as mere for other participants of the PLDP programme, illustrating the connection between these Pacific centres.

Bilateral meeting programme

- 6 While in Tonga, I met with Prime Minister Hon Hu'akavameiliku. Our conversation traversed several important topics, including our shared history, new leadership appointments in the NZDF, and the upcoming South Pacific Defence Ministers meeting here in Auckland in October.
- 7 Following the meeting, I met with the Minister of Meteorology, Energy, Information, Disaster Management, Environment, Climate Change, and Communications MEIDECC) Hon Fekitamoeloa Katoa Utoikamau. ^{\$9(2)(g)(i)}
- 8 Of particular interest was the detailed presentation on the Tongan Disaster Coordination Centre. This presentation walked me through the systems and processes that are utilised when Tonga faces the challenges of coordinating a large-scale response to an event.

Visit to Taliai Military Camp

9 My visit to Taliar Military Camp was an opportunity to view first-hand His Majesty's Armed Force's ^{s6(a)}



- 10 My time in Tonga, particularly attending the opening of the His Majesty's Armed Forces Leadership Centre, demonstrated our commitment to Tonga's ongoing leadership development. This was further magnified through being officially opened in the same week that saw both the King's Birthday Celebrations and Naval Fleet Review, both of which drew many international delegations.
