PROPOSED OVERSEAS TRAVEL: SINGAPORE, WEDNESDAY 31 MAY 2023 – MONDAY 5 JUNE 2023

Proposal

- I seek Cabinet's approval to travel in my capacity my capacity as Minister of Defence to attend the International Institute for Strategic Studies Shangri-La Dialogue: 20th Asia Security Summit ("the Shangri-La Dialogue") in Singapore.
- 2. Allowing for travel I would be away from New Zealand from Wednesday 31 May 2023 to Monday 5 June 2023.
- 3. Approval in-principle to travel has been granted by the Prime Minister and is subject to leave being granted by the Labour Whip.

Background

- 4. The Shangri-La Dialogue is the premier forum for Defence Ministers in the Indo-Pacific. The high levels of attendance from Ministers, defence force leaders, and senior security agency officials make it an important focal point for major power relationships and for discussion on contemporary strategic issues.
- 5. I have been invited to speak on the theme of 'Nuclear Dimensions of Regional Security' at one of the Simultaneous Special Sessions on 2 June. Speaking on this topic would visibly raise New Zealand's profile on security/defence matters and provide an opportunity to articulate our position on a topic of great relevance and interest. New Zealand has a unique perspective and the opportunity to share a Pacific voice.
- The Dialogue also provides opportunities for bilateral discussions with my counterparts throughout the summit (including with partners from the United States, United Kingdom, Canada partners from South East Asia).
- 7. I also have also been invited to attend group meetings in the margins of the event (for example, a Five Power Defence Arrangements Defence Ministers' breakfast s6(a)). These engagements provide a valuable opportunity to share perspectives on some

of the most crucial security issues facing our region with some of its most influential actors.

Ministerial Party

- 8. I would be accompanied by one staff member from my office.
- 9. A delegation from the New Zealand Defence Force | Te Ope Kātua o Aotearoa and the Ministry of Defence | Manatū Kaupapa Waonga would accompany me at departmental cost.

Report on Overseas Travel: Hon Andrew Little

I recommend that Cabinet note this report on my travel to Singapore from 31 May to 5 June 2023.

Report

- The purpose of my travel to Singapore was to attend the International Institute for Strategic Studies' (IISS) Shangri-La Dialogue the premier forum for Defence Ministers in the Indo-Pacific. This year marked the 20th anniversary of the Dialogue, and was attended by 34 government ministers including three heads of government.
- The Shangri-La Dialogue took place amid the ongoing conflict in Ukraine, the growing tensions between China and the United States, including AUKUS, and the ongoing conflict in Myanmar. It provided a key opportunity to underscore New Zealand's strategic interests in the Indo-Pacific region, and our enduring commitment to supporting global peace and security, as well as to gain a greater understanding of partners defence and security priorities.
- During the Dialogue's plenary sessions, I heard speeches from Ministers, senior officials, security experts and business leaders on topics ranging from the security implications of cyber and technological competition to developing models for cooperative security. The overall security of the Indo-Pacific, and the implications of the Ukraine conflict were key topics that dominated discussions at the Shangri-La Dialogue this year. A common thread throughout the plenary and special sessions was the need for both China and the United States to keep the channels of communication open.
- In the face of a more complicated and deteriorating strategic environment, speeches from countries across the region also featured references to increased defence spending and capabilities. This year Australian Prime Minister Anthony Albanese gave the keynote speech and outlined Australia's role in the Indo-Pacific referencing its recently unveiled Defence Strategic Review, and explaining the intention of AUKUS.
 - Idelivered a speech on the theme of 'Nuclear Dimensions of Regional Security' at one of the Simultaneous Special Sessions, which also included representatives from NATO, Pakistan, and the Republic of Korea. My speech was an opportunity to make clear New Zealand's longstanding and non-ambiguous position on nuclear weapons. I acknowledged New Zealanders' views on nuclear weapons are not shared by everyone and noted that our moral clarity should not be confused with wishful thinking. Rather, New Zealand is preparing to equip itself with trained defence personnel, assets and materiel, and increasing its modernisation and spending of capabilities across land, sea and air.

- In addition to attending the plenary sessions, I conducted 11 bilateral engagements including with counterparts from Singapore, Malaysia, Timor Leste, Canada, NATO, the United Kingdom and Ukraine. I also met with Chinese Minister of National Defense, General Li Shangfu, for the first time since our respective appointments.
- During the Dialogue, I also met with a number of key partners more informally, including a short pull aside with US Secretary of Defence, Lloyd Austin III and informal meetings with Australian Deputy Prime Minister and Minister for Defence, Richard Marles and Fijian Minister for Home Affairs and Immigration, Pio Tikoduadua.
- There was a strong Defence Industry presence at the Dialogue, and I met with representatives from Amazon, Microsoft and Lockheed Martin. My meeting with Lockheed Martin was a particularly useful opportunity to touch on the ongoing C130J project and the value of the long standing relationship New Zealand has with the company.
- Additionally, I undertook several multilateral engagements, such as the Five Power Defence Arrangements Defence Ministers' breakfast and Cohen Group Breakfast hosted by former US Secretary of Defence William Cohen. On the sidelines of the Dialogue, I also signed a Statement of Intent with my Japanese counterpart on 'Defence cooperation in maritime security, Humanitarian assistance and disaster relief and climate change in the Pacific Islands Region'.
